

CONSTITUTION FOR THE KICKAPOO HIGH SCHOOL THEATRE HALL OF FAME

ARTICLE I

PREAMBLE

Kickapoo High School Theatre Hall of Fame is a memorial to outstanding individuals who, through their exceptional achievements, have brought honor to themselves, their school and the community.

ARTICLE II

PURPOSE OF THE HALL OF FAME

The purpose of the Kickapoo High School Theatre Hall of Fame is to formally recognize outstanding contributions to the heritage and tradition of the Kickapoo Theatre program. It is the intent of this Hall of Fame to honor and preserve the memory of Kickapoo students, educators, and boosters whose achievements have brought recognition and honor to Kickapoo High School and its theatre program. A criterion for a former student's selection not only includes participation in the theatre while at Kickapoo High School, but post high school accomplishments in the field of television, film, or stage. Each inductee will receive a plaque highlighting the accomplishments of the inductee. Each inductee's picture will be displayed at Kickapoo High School.

ARTICLE III

ELGIBILITY REQUIREMENTS FOR THE HALL OF FAME NOMINEES

Candidates are eligible through at least one of the three classifications:

1. Former Student:

Individuals who participated in high school theatre and have achieved post high school accomplishments in the field of television, film, or stage. Nominees must be Kickapoo graduates.

2. Booster:

Private citizens who have been great theatre boosters and have made outstanding contributions to the theatre program at Kickapoo High School.

3. Educator:

Individuals who have made outstanding contributions to the Kickapoo High School Theatre Program—Such as: administrators, teachers, directors, etc. Nominees must be retired before consideration.

ARTICLE IV

NOMINATION SUPPORT CRITERIA

- 1) Number of years at Kickapoo
- 3) Productions Participated in
- 4) College or University Theatrical Achievements
- 5) Career Achievements, Accomplishments and Awards
- 6) Honors at the State, National or World level.
- 7) Testimonials from teachers, or citizens
- 8) Other

ARTICLE V

CANDIDATES FOR MEMBERSHIP

Candidates for membership in the Hall of Fame shall be former Kickapoo High School students and personnel who meet the requirements set forth in this constitution. In order to be inducted, candidate must receive a 2/3-majority vote from the Kickapoo High School Theatre Hall of Fame Committee.
